


# The Culpable Corporate Mind

This collection sets out the need for and shape of a radical reform of the legal framework regulating corporate culpable behaviour.

Given the increased primacy of corporations in modern commerce, an effective legal framework regulating culpable behaviour is essential. A broad array of traditional common law and equitable doctrines seek to prohibit and remedy commercial fraud. However, these concepts tend to demand high levels of proof of personal dishonesty or culpability on the part of defendants. This collection shows how restrictive and complex rules on attributing individual agents' intentions and knowledge to the artificial person are, essentially rendering them not fit for purpose. Arguing for the need to repurpose the law on corporate culpability, experts from private law, criminal law, and corporate law suggest what form this much needed radical reform should take. The collection looks at general fields such as equity and tort law as well as exploring specific sectors such as pharmaceutical industry and the digital field. Private, criminal and corporate lawyers, but academics and policy makers, will find this fascinating reading.
